3. Ever been disqualified from being a director of a company registered under the Companies Act 1955 or the Companies Act 1993;
4. Ever have been removed as a trustee of a trust by order of Court on the grounds on breach of trust, lack of competence or failure to carry out the duties of a trustee satisfactorily;
5. Physically or mentally incapacitated to the extent that I am unable to perform the duties of a Company Director;
6. Subject to a property order made under section 30 or 31 of the Protection of Personal Property Rights Act 1988;
7. Committed, in the last 10 years, an offence punishable by more than 3 years imprisonment (not including an offences to which I was eligible for the purposes of the Criminal Records (Clean Slate) Act 2004).
